Open Enrollment, which runs October 15th to December 7th is the time to make these changes. Kindly complete the enclosed Standalone Part D Review form and return the form to update your plan. Or you can visit www.TheSeniorHealthAdvisor.com and complete your form online at the 2027 Enrollment Page. Complete the form and click the submit button. The form cannot be used as a printout. Email me a notice when you submit the form so I can check if it went through.

As in years past Dan Downs, Crystal Figlinski and Bree Kelly will be handling the drug reviews. The forms are mailed back to me. I log these and forward them to Dan. Important Change: Medicare is cracking down on call centers in 2027 and requires all reviews and enrollment calls to be recorded by every agency and agent including me and Dan.

There are certain plans we will NOT be working on during Open Season: Your Medicare Supplement plan can be revised on any month, so we delay these until the 1st Quarter of 2027. The same goes with dental or vision plans, time is limited during Open Enrollment, and we will address these requests in the first quarter of 2027.
